PART - I
INSTRUCTIONS TO BIDDERS

1. GENERAL

- (i) Name of the work is “Estate Cleaning Activity for 12 Zones of Integrated Vaccine Complex at HLL Biotech Limited, Chengalpattu, Tamil Nadu”.
- (ii) Tenderers are advised to inspect and examine the site and its surrounding and satisfy themselves before submitting the tenders and obtain all necessary information which they feel is necessary to submit their tender.
- (iii) The bidders are advised to quote their rates for executing the work.

2. SUBMISSION OF TENDER

i) **“Part-I- Technical Bid”**

The documents specified under Clause No. 3 shall be scanned and uploaded to the **online e-Tendering portal**.

ii) **“Part-II- Price Bid”**

The Schedule of Quantities shall be filled in strictly as per the format provided in the **online e-Tendering portal**.

3. QUALIFYING CRITERIA

Tenderers having following valid documents will be technically qualified and considered for opening of their price bid. Technically qualified parties have no right to claim for award of the work. The HBL reserves the right to cancel or award the work to any party/tenderers.

4. The price bids of the bidders who do not meet the qualifying requirements in the technical bid will not be opened.

5. VALIDITY OF OFFER

Tender submitted by tenderers shall remain valid for acceptance for a minimum period of **120** days from the date of opening of the tenders. The tenderers shall not be entitled during the said period of **120** days, to revoke or cancel their Tender or to vary the Tender given or any term thereof, without the consent in writing of the Owner. In case of tenderers revoking or canceling their tenders or varying any terms in regard thereof without the consent of owner in writing,

6. ACCEPTANCE/ REJECTION OF TENDER

- a. HBL does not bind itself to accept the lowest tender.
- b. The HBL also reserves the right to accept or reject any or all tenders without assigning any reason whatsoever.
- c. HBL also reserves the absolute right to reject any or all the tenders at any time solely based

on the past unsatisfactory performance by the bidder(s) the opinion/decision of HBL regarding the same shall be final and conclusive.

It will be obligatory on the part of the tenderer to sign the tender documents for all the components & parts. After the work is awarded he will have to enter into an agreement on Performa to be provided by the HBL for work awarded, on a non-judicial stamp paper of requisite value at his own cost within ten days from date of receipt of acceptance order or before the work is undertaken.

PART - II

SCOPE OF WORK:

The scope of work for the Estate Cleaning Activity for 12 Zones of Integrated Vaccine Complex at HLL Biotech Limited, Chengalpattu, Tamil Nadu as follows as,

A comprehensive mass-cleaning activity is proposed to be undertaken across the **45 Acres** estate of Integrated Vaccine Complex (IVC). The entire area of Integrated vaccine complex has been divided into 12 zones and the details of the zones are as under

1. ETP and STP Area
2. Animal House Area
3. Empty space in-between Animal House and BCG Block
4. Around MBB and BCG Blocks
5. Around Utility and MR Blocks
6. Around Substation
7. Area Heavy Vehicle Parking Area
8. Around Secondary Packaging and Warehouse Blocks
9. Around Pretreatment and VVF Blocks
10. Around Admin Block and Gate office
11. Around BVF Bulk Block
12. Around Central Laundry and Rabies Bulk Block

There will be a designated Zone in-charge for each zone from HLL Biotech Limited.

The Contractor / vendor shall follow the following procedures for the cleaning activity

1. Removal of Unwanted Bushes and Trees

- All unwanted bushes, shrubs, and small trees must be removed completely, including roots.
- Trees located within **2 feet distance** from the building must be trimmed or branches cut as required.

2. Tree Removal Approval Responsibility

- If any tree cutting, removal, or trimming is required, the **contractor is fully responsible** for obtaining all necessary approvals.
- Approvals must be obtained from the **Forest Department, Greenhouse/Horticulture Department**, and other relevant statutory authorities as per need and if applicable
- No tree should be removed without **proper written approval** from these departments and from the respective zone in-charges.
- Any legal issues, penalties, or violations arising from unauthorized tree removal will be the **sole responsibility of the contractor**.

3. Street Light Clearance

- All branches covering or touching streetlight poles must be trimmed and cleared to ensure proper lighting.

4. Complete Cleaning of Vegetation

- All unwanted bushes, weeds, and small trees must be removed completely from the roots.
- The cleaned area must appear **flat, neat, and open**, similar to a playground surface.

5. Waste Material Handling

- All garden waste, removed branches, and debris must be collected and safely disposed of as per company guidelines.
- Iron, steel, and other scrap materials must be segregated in the **dedicated location** confirmed by the HLL Biotech team.
- The contractor must support **moving and arranging** these materials within the tender scope.

6. Final Land Condition

- After cleaning, the land must be left **neat, levelled, and ready for future garden/plantation development**.

7. Zone-Wise Cleaning & Approval Process

- The Company Estate area is divided into **12 cleaning zones**.
- HLL Biotech will form a **committee** for each zone to monitor and verify the cleaning work.
- Clearance for initiating work in a particular zone shall be taken from the zone in-charge and Admin Department of HBL.
- After completion of each zone, the **building in-charge/zone committee member** and Admin must inspect and provide **written approval**.
- Payment to the vendor will be released **zone-wise**, only after approval is received.
- Tree cutting will be allowed only after **Forest/Greenhouse Department permissions** are confirmed by the contractor.

8. Outside Compound Cleaning

- The contractor must thoroughly clean the **entire outside boundary** of the company compound.
- Cleaning_route:
ETP & STP Outer Area → Up to Substation (near TNEB) → End of Compound Boundary
- All unwanted bushes, shrubs, and vegetation must be removed along this entire stretch.

9. Damage Responsibility During Mass Cleaning

- Any damage caused by the vendor to **pipelines, civil structures, drains, cables, streetlight wiring, compound walls, roads, or any company infrastructure** will be the **full responsibility of the vendor**.
- The vendor must **repair and restore** all damaged items at **their own cost**, with no additional charges claimed.
- Vendor vehicle movement must be controlled. Any damage caused by **vehicle/machinery** will also be the vendor's responsibility.

10. Worker Safety & Responsibility

- All workers must be provided with adequate safety equipment (PPE: gloves, boots, helmets, masks).
- The contractor is fully responsible for the safety of their workers.
- Any injury, accident, or hospital expense for workers is **100% contractor responsibility**.
- The company will support only **emergency transportation** and **snake venom first-aid**.
- No claims or compensation from third-party contractors will be accepted by the company.

PART - III
GENERAL CONDITIONS OF CONTRACT

The General Conditions of Contract are as under:

1.1 Delay and extension

If the work is delayed by force majeure or any other cause in the absolute discretion of Employer, which is beyond the Agency's control, the agency shall immediately upon the happening of such event contributing to delays give notice thereof in writing to HBL/Engineer-in-Charge but shall nevertheless use constantly their best endeavors to prevent or make good the delay and shall do all that may be reasonably required to the satisfaction of HBL to proceed with the work.

Request for extension of time shall be made by the Agency in writing within seven days of the happening of the event causing delay. The survey Agency shall also indicate with any such request, the period for which extension is required. In any such case HBL may give a fair and reasonable extension of time for completion of individual items or group of items of work for which separate period of completion is specified in the contract as a whole, but it shall be the sole discretion of the Employer to grant or refuse such extension.

The decision of HBL in regard to the extension will be communicated to the Agency in writing within a reasonable time but no compensation or any extra amount shall be paid for such extension granted by HBL.

1.2 Compensation payable for delay in completion and risk prejudice clause

The Agency shall be liable to pay compensation to HBL in case of delay in fulfilling obligation under this agreement for causes solely attributable to the Agency @ 1% (One percent) of contract amount per week of delay subject to maximum of 5%(five percent only) of the total contract price towards their contract.

1.3 Risk Prejudice Clause

In case progress of any part of Agency's work is found to be unsatisfactory by HBL at any time during the execution vis-à-vis the terms of contract, HBL shall give the Agency a fortnight's notice in writing asking for their plans for remedying the situation and to complete the job within the time decided by Engineer in Charge/HBL, subject however to the conditions that the entire work falling within their scope of work shall be completed within the stipulated time. On the failure to remedy the situation as per agreed time with HBL, HBL shall have the right to withhold that portion of the work and get the same done at the risk and cost of the Agency after giving one weeks' notice.

1.4 Arbitration

If at any time any doubt, question, dispute or difference whatsoever, shall arise between the Agency and HBL upon or relating to or in connection with this contract, either of the parties may give the other notice in writing of the existence of such doubt, question, dispute or difference and the same shall be referred to the Engineer-In- Charge, HBL or it's nominee as Sole Arbitrator. The decision of the sole arbitrator thereon shall be final, conclusive and binding upon the parties to dispute. The party invoking arbitration shall specify the dispute or disputes to be referred to the arbitration under the clause together with the amount or amounts claimed in respect of each of dispute.

1.5 Jurisdiction of Court

The courts at Chengalpattu shall have jurisdiction to entertain and adjudicate any disputes.

1.6 Termination of Contract

HBL reserves the right to terminate, or postpone the work on account of fulfillment of contractual obligation(s) or any sufficient cause, HBL being sole judge of the same. The Agency shall be paid for the useful work done up to the date of termination. HBL shall determine the credit to be given to the agency for the value of the work executed by the Agency. The Agency shall give HBL all the data, compiled report, drawings etc. prepared by them till the date of termination before the final dues are paid to the Agency. Even after the termination of agreement, the Agency shall continue to cooperate with HBL to such a reasonable extent as may be necessary to clarify or explain any reports or recommendations in documents or detailing made by them.

1.7 Breach of Trust

Unless otherwise directed by HBL specifically, the Agency shall not contact directly or indirectly the client or any other authorities connected with the project. Non-compliance of this clause shall be treated as breach of trust resulting in the termination of contract between HBL and the Agency for which without any prior notice to him. In such event, no job will be entrusted to him in future by HBL.

1.8 Discussions with HBL and Approvals

The Agency shall make themselves available at reasonable notice to be present for discussions with HBL. The Agency shall also provide assistance, advice and information to HBL as may be required from time to time for discussions with HBL officials connected with the work other agencies or

The Agency shall get approved the work done by him at every stage throughout the period from HBL. However, such approval by HBL shall not be deemed to absolve the Agency of the total responsibility of the correctness and soundness of the work and other obligations under this contract.

1.9 Guarantee and liability of the Agency

The Agency shall be liable for all consequence of errors and omissions arising from errors solely attributable to Agency or on the part of their employees to the extent and with the limitation specified by HBL.

1.10 Periodical Progress Report

The Agency shall prepare and submit periodical progress reports and status of works being performed by them. Such submissions of reports and review and approvals, if any, thereof by HBL shall not be deemed to absolve the responsibilities of the completion of the assignment.

1.11 Unit Rates

Contractor must ensure to quote rate of each item, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "**0**" (**ZERO**). The Unit rates quoted shall remain firm throughout the validity of the contract. The rate shall include cost of materials, machineries, labour (including lodging and boarding charges), removal of bushes and vegetation as required to carry out and complete the scope of work without any hindrances, tools and equipment's, transport charges, taxes, royalties, octroi, GST etc. payable on all transactions for the due performance of work under this contract. The rates shall be given in the schedule, as specified **herein itself positively**. No additional cost or escalation shall be paid on whatever accounts it maybe.

Rate quoted shall be binding for any quantity of each of the items.

1.12 Variation in scope of work and schedule of quantity

The scope of work & schedule of quantities may vary to any extent. The rates quoted by the Agency shall remain firm for the complete job as directed by the Engineer in Charge.

1.13 Mobilization Advance

No Mobilization advance shall be paid.

1.14 Tax

Tax shall be deducted from Agency's bill as per rules.

1.15 Submission of Tender:

1.16 Completion Time

Total time period for completion of job will be **20 days** from the date of the work order issued to party

1.17 Terms of Payment

- I. 100% of the payment shall be released on the submission of final bill (inspected and verified by Engineer In-charge), along with completion certificate from concerned authorities and original invoices.
- II. All statutory payments should be made by the contractor and the same shall be reimbursed on recipient of valid documents.

Tax Deduction: All statutory deductions like GST, Income Tax, Works Contract Tax, E.S.I., P.F. or any other government-imposed liabilities shall be borne by the Contractor (as applicable at the time of execution of job) and shall be deducted from each bill submitted by the Contractor
